

INFORMATION ON THE PROCESSING OF PERSONAL DATA in the Sports Club BEACHKLUB PRAHA, association

pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of

of natural persons with regard to the processing of personal data and the free movement of such data and on the abolition of

Directive 95/46/EC (General Data Protection Regulation) ("GDPR")

II. Scope of personal data processed:

We process your following personal data:

- 1. the name and surname, or the name and surname of the legal representative,
- 2. Birth number (for grant purposes only),
- date of birth,
- address of place of residence (for a citizen of the Czech Republic, address of permanent residence),
- 5. address for delivery (billing and, if applicable, delivery),
- 6. your nationality (only if you are a foreigner),
- contact details (especially email address, phone number, Facebook contact, if applicable), or contact details
 of the legal representative,
- 8. sex,
- T-shirt size,
- 10. information on the validity of the registration,
- 11. IP address,
- 12. cookies,
- 13. your personal account number,
- 14. the amount you are in arrears with your membership fee, including the date you are in arrears,
- 15. the date of membership in the Society,
- 16. type of membership in the Society,
- 17. the amount and date of payment of the membership fee,
- 18. sports results,
- 19. Photographs,
- 20. information about the services you have ordered, including services that have been ordered in the past,
- 21. video footage,
- 22. audio recordings,
- 23. details of your bank connection, payment and transaction history,
- 24. personal data listed in your consent to the processing of personal data (especially name, surname, date of birth, photographs, video recordings and sound recordings taken at events and competitions organized by the Association and other association and marketing activities of the Association, sports results)

("Personal Data").

Please note that if you refuse to provide the Personal Data referred to in points 1. to 7. above, you cannot become a member of the Society.

We obtain personal data from you, from publicly available registers and records or other publicly available sources and, where applicable, from third parties, if this is necessary for the formation and implementation of your membership in the Society or for the formation of a contract and the performance of contractual obligations arising from a contract concluded with you, if this is provided for by law or if you have given your consent.

III. Legal Basis and Purposes of Processing Personal Data:

The legal basis and purposes for processing Personal Data are as follows:

1. Processing of Personal Data for the conclusion and performance of a contract (Article 6(1)(b) GDPR):



- the processing and registration of your application to the Society and the negotiation of your admission as a member of the Society and the termination of your membership,
- the exercise of your membership rights as a member of the Society,
- fulfilling the purpose for which the Society was founded and related activities (e.g. organizing events and competitions, your participation in events and competitions organized by the Society, applications for subsidies, grants, etc.),
- the formation of a contract and the fulfilment of contractual obligations on the basis of your order for services provided by the Association (especially sports and physical education services, such as sports camps, suburban camps, training sessions, tournaments...),
- Your registration and access to the user interface or booking system available on the website used by the Society (www.beachklub.cz) and the operation and management of this user interface or booking system by the Society or third parties.
- 2. The legal basis for processing in this case is the formation and performance of a contract. For this purpose, the personal data listed in Article II under points 1., 2. (the birth number is processed only for the purposes of grant titles), 3. to 10., 13. to 18., 20. and 23. are processed. Processing of Personal Data for the performance of our legal obligations (Article 6(1)(c) GDPR):
 - keeping records of the Society's membership base,
 - entry of data and changes thereto in the register of sports organisations and other persons applying
 for the provision of support pursuant to Section 6b of Act No.115/2001 Coll., on the promotion of
 sport, as amended (hereinafter referred to as "ZOPS"), athletes, coaches and sports facilities for
 whose activities support is requested, pursuant to Section 3f of the ZOPS,
 - the fulfilment of other obligations arising from legal regulations (in particular Act No. 586/1992 Coll., on Income Taxes, as amended, Act No. 563/1991 Coll., on Accounting, as amended, Act No. 499/2004 Coll., on Archiving and Filing Service and on Amendments to Certain Acts, as amended, Act No. 89/2012 Coll., Civil Code, as amended, ZOPS) and/or from the Articles of Association of the Association.

The legal basis for processing in this case is the performance of obligations imposed on us by law. For this purpose, the personal data listed in Article II under points 1, 3, 4, 6, 10, 14 to 17, 20 and 23 are processed.

- 3. Processing of Personal Data to protect our legitimate interests (Article 6(1)(f) GDPR):
 - asserting or defending our legal claims,
 - protection of the property and rights of the Society, the members of the Society and the company SPORTZONE, a.s., with registered office at Horáčkova 1100/14, Krč, 140 00 Praha 4, ID No.: 27596001 (hereinafter referred to as "SPORTZONE, a.s.") (holder of the domain www.beachklub.cz and also the operator of the beach volleyball courts located at Horáčkova 1100/14, Krč, 140 00 Praha 4, which is used by the Society for its activities),
 - internal administrative purposes of the Society, ensuring the functioning of the Society and its bodies and communication with members of the Society (e.g. sending invitations or non-commercial communications such as newsletters),
 - joint participation of members of the Society at individual sporting events of the Society (especially with regard to the different sporting level and friendship ties of the members of the Society), whereby for this purpose the names and surnames of the members of the Society registered for a particular sporting event of the Society are listed in the user interface, respectively in the iSport booking system,
 - creation of historical, sporting and similar documents documenting the activities of the Society (e.g. competition results, annual reports, etc.),
 - Processing of cookies that are necessary for the proper operation of the <u>www.bvkcamps.com</u> website
 - promoting the sale of the Society's services, only if the services offered are related to the services you
 originally purchased and to the extent that you can reasonably expect similar services to be offered.

The legal basis for processing in this case is the pursuit of our legitimate interests. For this purpose, the personal data listed in Article II under points 1, 3, 4, 5, 7, 11, 12, 14, 21 to 23 are processed.

- 4. Processing of Personal Data on the basis of consent (Article 6(1)(a) GDPR):
 - Processing of cookies that are not necessary for the proper operation of the www.beachklub.cz and wwww.
 - We process the Personal Data specified in the consent given by you or your legal representative for the purposes set out in the Personal Data Processing Agreement. your legal representative, granted consent to the processing of Personal Data, and under the conditions and to the extent set out in such consent, in particular in the consent granted for the purposes of conducting marketing activities of the Society and promoting and supporting the activities of the Society and presenting and informing about planned and implemented events and competitions organized by the Society and other activities of the Society, in particular on promotional materials, on billboards, on websites used by the Society, on social networks (e.g. Facebook, Instagram, etc.), on the Internet, in the press, and possibly in other information and promotional materials and media (e.g. radio, television broadcasts). You give your



consent voluntarily and can withdraw it at any time. Failure to grant consent or its withdrawal has no consequences for the establishment and duration of your membership in the Society, or for the conclusion of a contractual relationship with the Society or for the performance of an ongoing contractual relationship with the Society and the use of the Society's services, or for your participation in events and competitions organized by the Society or in other activities of the Society. Withdrawal of consent does not affect the lawfulness of processing based on consent given before its withdrawal. You, or your legal representative, may withdraw your consent in person at the registered office of the Society, in writing by sending a form bearing your signature, or the signature of your legal representative, to the registered office of the Society or to the above-mentioned e-mail address of the Society (the form is available on the website used by the Society: www.beachklub.cz), or by telephone at the above-mentioned telephone number.

In this case, the legal basis for processing is the consent given by you or your legal representative to the processing of Personal Data. For this purpose, the Personal Data referred to in Article II under points 12 and 24 are processed.

IV. Period of processing of Personal Data:

We process personal data for as long as is necessary for the purposes of processing. The Personal Data will be processed and stored for the duration of your membership in the Society and for a maximum of 10 years from the date you cease to be a member of the Society, unless it follows from the law that we must keep certain Personal Data for a longer period. In the event that you do not become a member of the Society, the Personal Data will be processed and stored for a period of 3 months from the date of rejection of your application to the Society or your non-acceptance as a member of the Society. In addition, Personal Data will be processed and stored for the duration of your contractual relationship with the Society and for a maximum of 10 years from the date of termination of the contractual relationship, unless it follows from legal regulations that we must keep certain Personal Data for a longer period. We process Personal Data relating to the protection of our legitimate interests depending on where the legitimate interest lies, unless the law requires us to keep certain Personal Data for a longer period. Personal Data that we process on the basis of your or your legal representative's consent to the processing of Personal Data is only retained for the duration of the purpose for which the consent was given or for the period for which the consent was given, unless the consent to the processing of Personal Data given by you or your legal representative is withdrawn before the expiry of that period. In cases where the Personal Data are part of historical, sporting and similar documents documenting the activities of the Society (e.g. competition results reports, annual reports, etc.), they will be kept for the duration of the Society's existence.

V. Recipients of personal data:

- 1. We transfer Personal Data to the following processors:
 - to the relevant sports associations (National Sports Agency, Prague Volleyball Association, or Czech Volleyball Association).

for the purpose of

- keeping records of the membership base of the sports association on the basis of its internal regulations,
- sporting activities and identification at competitions and
- applying for subsidies, grants, etc.
- 2. We also transfer personal data, if necessary, to the relevant state and local government authorities (municipalities and regions), as well as to other public authorities (e.g. courts).
- 3. We also transfer Personal Data to the following processors: to VašeWebovky s.r.o., U Sluncové 711/8, Karlín, 186 00 Prague 8, ID No.: 227 73 681 (operator of the user interface, or the iSport reservation system), VSHosting s.r.o., Sodomkova 1579/5, Hostivař, 102 00 Prague 10, ID No.: 227 73 681, SPORTZONE, a.s. (holder of the domain www.beachklub.cz and also the operator of the beach volleyball courts located at Horáčkova 1100/14, Krč, 140 00 Prague 4, which is used by the Society for Social Activities), of SecurityNet.cz s.r.o, with registered office at U Velorexu 1301, 564 01 Žamberk, ID No.: 27501418, or to external providers of IT services, accounting services, tax consulting services, legal services and marketing services, and possibly to other processors.

Upon your request, we will provide you with a list of our processors.

We process personal data only in the Czech Republic and do not transfer it abroad or to international organizations, except in cases where the transfer of personal data is necessary for your participation in a sporting event held abroad, in which case only the data necessary for this participation are transferred (typically the data listed in Article I under points 1, 3, 4 for the purpose of arranging accommodation at the venue of the sporting event).

VI. Your rights in relation to the processing of Personal Data

You understand that you may exercise the following rights at any time during the processing of Personal Data:



- the right of access to your Personal Data, consisting of the right to obtain confirmation from us as to
 whether or not Personal Data concerning you is being processed by us and, if so, the right to access your
 Personal Data and the right to obtain a copy of your Personal Data that we are processing (Article 15 GDPR);
- the right to rectification and completion of Personal Data concerning you in the event that you discover
 that we are processing incorrect or incomplete Personal Data about you (Article 16 GDPR);
- the right to erasure of your Personal Data ("right to be forgotten") once your Personal Data is no longer necessary for the purposes for which it was collected or otherwise processed, once you withdraw your consent to processing and there is no other legal basis for processing, if you object to processing on the basis of legitimate interest and there are no overriding legitimate grounds for processing on our part, if you object to the processing of Personal Data for direct marketing purposes, if your Personal Data is processed unlawfully, if the Personal Data must be erased to comply with a legal obligation under European Union or Czech law, or if the Personal Data was collected in connection with the offer of information society services (Art. 17 GDPR);
- the right to restrict the processing of your Personal Data if the Personal Data processed is not accurate, the processing is unlawful, the Personal Data processed is not necessary for the purposes for which it was processed, or you object to the processing (Article 18 GDPR);
- the right to the portability of your Personal Data, consisting in the fact that if we process your Personal
 Data on the basis of your consent or for the purpose of performance of a contract and at the same time the
 processing is automated, you have the right to obtain such Personal Data in a structured, commonly used,
 machine-readable format and transfer it to another controller (Article 20 GDPR);
- the right not to be the subject of any decision based solely on automated processing, including profiling, which has legal effects for you or significantly affects you in a similar way (Article 22 GDPR). In this context, we hereby inform you that no automated decision-making, i.e. decision-making based solely on automated processing (including profiling), which has legal effects for you or significantly affects you in a similar way, takes place in the Society;
- the right to withdraw your consent to the processing of Personal Data, whereby the withdrawal of consent has no consequences for your membership in the Association and/or your contractual relationship with the Association and the use of the Association's services for which such consent is not required, and the lawfulness of the processing of Personal Data based on your consent prior to its withdrawal is not affected by the withdrawal of consent (Art. You, or your legal representative, may withdraw your consent in person at the address of the registered office of the Society, in writing by sending a form bearing your signature, or the signature of your legal representative, to the address of the registered office of the Society or to the above-mentioned e-mail of the Society (the form is available on the website used by the Society: www.beachklub.cz), or by telephone at the above-mentioned telephone number.
- the right to be notified of a Personal Data breach where a particular Personal Data breach is likely to result in a high risk to the rights and freedoms of natural persons (Article 34 GDPR);
- the right to file a complaint with the Office for Personal Data Protection, located at Pplk. Sochora 27, 170 00 Prague 7, tel. +420 234 665 111 (www.uoou.cz), which is the supervisory authority in this area, or to another competent supervisory authority of a Member State of the European Union, which is responsible for supervising compliance with the obligations set out in the GDPR (in particular, the supervisory authority in the Member State of your habitual residence, place of employment or place where the alleged violation occurred), if you believe that the processing of your Personal Data has violated the obligations set out in the legislation on the protection of personal data (in particular the GDPR) (Article 77 of the GDPR).

You also have the right to object to the processing of your Personal Data if your Personal Data is processed for the purposes of the performance of a task carried out in the public interest or in the exercise of official authority, for the purposes of our legitimate interests or the legitimate interests of a third party, or for direct marketing purposes, including profiling, in order to tailor the offer to your needs and improve the quality of the services provided. If you object, we will not process your Personal Data until we can demonstrate compelling reasons for processing that override your interests or rights and freedoms or for the establishment, exercise and/or defence of our legal claims. If you object to processing for direct marketing purposes, we will no longer process your Personal Data for these purposes (Article 21 GDPR).

You may exercise the above rights in person at the address of the Society's registered office, in writing by letter sent to the address of the Society's registered office or via the Society's e-mail address mentioned above (you can use the form available on the website used by the Society: www.beachklub.cz), or by telephone at the above telephone number.
